NEWLANDS AND IRRIGATION

The Republican candidate for the United States senate, in his speeches throughout the state, has attempted to minimize Senator Newlands' efforts in the fight for irrigation legislation, and claims that most of the credit was due to President Roosevelt for the enactment of the reclamation law. In this connection it might be interesting for the people of Nevada to know what President Roosevelt himself has said about Senator Newlands' efforts in this regard. In an article on Irrigation sent out by the Outlook company early in this year, and published generally throughout the country, President Roosevelt said:

"Senator Francis G. Newlands of Nevada fought hard for the cause of reclamation in congress. He attempted to get his state to act, but when that proved hopeless, to get the nation to act. By far the most effective of these senators in drafting and pushing the bill, which became known by his name, was Newlands."

MORE OF "ME AND GOT"

Pastor Russell, one of the most famous divines of New York, whose sermons and word are taken as creed in half of the homes of the east, is out in terrible invective against the war now progressing in Europe and against the rulers who brought it about. During the course of a sermon preached last Sunday in his New York church he produced a report of a proclamation which he stated was read to the troops of Kaiser Wilhelm in Poland, wherein the kaiser proclaimed he was the representative of the Jehovah. Prefacing the reading of the proclamation, Pastor Russell said:

"But notwithstanding this knowledge, the Divine character is still blasphemed. The kings of the earth, who told during the 'dark ages' that they were the sword of the Lord and servants of the church, have not been undeceived. Hence the czar of Russia, the head of the Greek church, believes he is working out a divine destiny; the British, under King George, are equally convinced that are working out a great destiny as God's kingdom. The German kaiser is similarly deceived into thinking that he is the sword of the Almighty. Mark his latest reported proclamation to his army in Poland which reads:

"Remember you (my army) are God's elect. God's spirit has descended on me because I am emperor of Germany. I am Jehovah's sword. His representative, the instrument of the Most High. Woe and death be to those who resist my will and to all who do not believe my mission and to cowards in my army. The enemies of the German people shall perish. God demands their destruction. He it is who through me commands you to fulfill His will."
